PICTURESQUE B. & O.

Bishop Perry's Impressions of his Trip to New York via Washington.

A lengthy article from the pen of Rev. William Stevens Perry, Bishop of Iowa, was recently published in the Iowa Churchman, descriptive of his journey from Chicago to New York via Washington. Among other things he says: "One traveling eastward from Chicago, via the picturesque Baltimore & Ohio Railroad, finds rest and comfort in the vestibuled Pullman limited trains on which travel is no longer irksome, but luxurious. There are two of these trains daily from Chicago, one leaving at 10 a. m., and the other at 2:55 p. m. It was on the morning train that we began our pleasant journey across the plains and over the Alleghenies for New York. We had the enjoyable anticipation of going via Washington, for the Baltimore & Ohio alone, of all the many routes between the seaboard and the lakes, passes directly to and through the Capitol City.

"It was night when we crossed the Ohio river and began the ascent of the Alleghenies, on the summit of which are the twin resorts, Deer Park and Oakland. The last named is a pretty village shut in by towering mountains. A pretty church shows the visitors at Deer Park take their religion with them into the country. The handsome cottages grouped about the hotel, the fine walks and drives in every direction, the salubrity of the air, and the coolness which is obtained when all the world is in the heat of the term make this an ideal spot for summering. At the base of the mountains we entered the Potomac valley, which was debatable ground during the civil war. Here the farms and fields we cross, the ravines we tread, as we sped on to Washington, have their historic associations with that interecne strife that pitted the Blue against the Gray. Across the mountains and down the Potomac we were greeted by a constant succession of most magnificent views which have gained for the Baltimore & Ohio the sobriquet of 'Picturesque B. & O.'

"Our route from Washington to New York was via the Royal Blue Line of the Baltimore & Ohio, which is composed of the staunchest and finest coaches, parlor and sleeping cars of the Pullman Company, vestibuled from end to end, and protected by Pullman's improved anti-telescoping device. CHAPTER 76.

AN ORDINANCE AUTHORIZING THE APPOINTMENT AND PRESCRIBING THE DUTIES OF A STREET COMMISSIONER. SECTION 1. Be it ordained by the President and Board of Trustees of the Village of Dwight, that the President of the Village of Dwight, and he is hereby authorized to appoint, by and with the advice and consent of the Board of Trustees, one street commissioner, who shall hold his office for and during the municipal year in which he shall be appointed or until his successor is appointed and qualified; provided, however, that any street commissioner may be removed at any time, at the discretion of the president of the said village, and in case of any such removal the president of said village shall report such removal, together with his reasons therefor, to the next regular meeting of the Board of Trustees, and the every street commissioner so appointed shall be commissioned by warrant under the corporate seal, signed by the clerk and the president of the said village.

SEC. 2. Before entering upon the duties of his office the said street commissioner shall take and subscribe the following oath or affirmation: I, \_\_\_\_\_, do solemnly swear (or affirm, as the case may be) that I will support the constitution of the United States and the constitution of the State of Illinois, and that I will faithfully discharge the duties of the office of street commissioner of the Village of Dwight, according to the best of my ability.

SEC. 3. The street commissioner shall also, before entering upon the duties of said office, execute a bond, with security to be approved by the Board of Trustees, in the penal sum of Five Hundred Dollars, conditioned for the faithful performance of the duties of said office, and the payment of all moneys received by such officer, according to law and warrant of the Board of Trustees, and to deliver within five days after notification and request, to the Board of Trustees, all moneys received by him, and to the President of said Village, all property, books and effects of every kind and description, and all other things belonging to the said Village or pertaining to his said office, which said oath or affirmation so watered and said bond shall be filed in the office of the Clerk of said Village.

SEC. 4. Any person who may have been such Street Commissioner, to deliver to his successor in office, if there be one, and if there be none, to the Board of Trustees, to the President of said Village, all property, books and effects of every description, or any or either thereof, and all other things belonging to the said Village or pertaining to his said office, shall render such person liable to the damage of the Village, to the full or penalty of not less than \$25 nor more than \$100.

SEC. 5. Such Street Commissioner shall be a conservator of the peace under 412 art. VI of the constitution of the State of Illinois, and he shall be and he is hereby invested with all the power and authority, and shall perform all the duties, and shall be subject to the penalties of a policeman of said Village of Dwight, and all other laws, ordinances, rules and regulations, and shall execute all warrants for the violation of any of the ordinances of said Village, and all other laws, ordinances, rules and regulations, and for such purposes such Street Commissioner is hereby clothed with all the powers and authority of a policeman of said Village, and he shall be and he is
