## Town Board.

The city council met in regular session Tuesday, Oct. 30th, 1894. President Haise being in the chair. After passing the bills against the town, and instructing the judiciary committee to use their discretion in settling or fighting the Hanson case, against the Village of Dwight, also receiving the report of the sewer committee, showing that two filters were now in full operation, and were sufficient for any emergency, the Board then took up the question of the public park. The chairman of the committee appointed by the Village, not being present, and the balance of the committee not being ready to report, the committee from Rentree submitted a report, which was read by members of the committee present, as being substantially correct, as to facts. The report read as follows:

Dwight, Ill., Oct. 8, 1894.  
To the President and Honorable Members of the Board of Trustees of the Village of Dwight: Gentlemen—The joint committee called upon by Mr. McWilliams, Monday, Oct. 8, 1894, and after presenting the reasons for the committee being appointed, requested him to make a new deed to take the place of a deed formerly executed and delivered to a former village board for the property described in said deed, the same to be used as a public park.

They were simply given to understand, by Mr. McWilliams that he had nothing to say in regard to it, further than what he had formerly said to a committee formerly appointed by the village of Dwight for a park, when there was a sufficient amount provided for the improvement of the park, and as your committee understood it, this was the deed that was given to the village. This is all your committee could get him to promise. We inferred from what he said, that we expected, unless the village did something, that the land described in the deed, would revert back to him.

We recommend that some action be taken to determine whether or not the village of Dwight is to have the land described in the deed as executed Sept. 1891, as a public park, and further recommend that the judiciary committee be authorized and instructed to immediately commence such action as is necessary to determine the question involved.

Then the chairman of the committee from Rentree Addition, Mr. W. H. Ketcham, stated to the Village Board that he presented their financial condition, and therefore made the proposition in writing, which was presented to the Board, and read as follows:

Dwight, Ill., Oct. 9, 1894.  
To the President and Honorable Members of the Board of Trustees of the Village of Dwight: Gentlemen—Inasmuch as the committee, formerly appointed by the Village Board, together with the committee appointed by the residents of Rentree Addition, having called upon Mr. McWilliams, and requested him, to make a new deed to take the place of a deed formerly executed and delivered to the village of Dwight, and accepted by the Village Board on Sept. 1, 1891, and have failed to get a new deed from Mr. McWilliams, I, therefore, as a citizen of Dwight and a resident of Rentree Addition, do hereby make the following proposition, as an attorney, to the Village of Dwight.

If the Village Board will authorize and instruct their judiciary committee to commence an action to have the court declare that the strip of land described in the deed executed by the Village Board, Sept. 1, 1891, was donated and is a public park, I will give my services as an attorney, free of charge, and will further agree that should any additional counsel be required, to employ the same and pay for the same out of my own pocket; also, I will pay all the costs in advance necessary to carry the suit to a final and successful termination, believing that immediate action should be taken in order to save the property from being lost. Mr. McWilliams, by reason of his having taken possession of the same since the deed was known to have been given, and that he has not been notified, I further agree, that if this written statement is not a sufficient guaranty that I will pay the expenses of the suit, the case shall revert to the village, I will execute to the village any bond or obligation that is required by them as a guaranty that I will be held to the same terms. Hoping that this will receive favorable action upon your part, I am,

Mr. Ketcham stated to the Village Board that the costs in the case, his judgment, would not exceed \$25.00 outside of attorney's fees. He also presented to the Board for inspection a map of Rentree Addition, dated Aug. 27, 1891, and also called the attention of the Village Board to the record of a meeting of the Board, Sept. 1, 1891, which read in part as follows:

Dwight, Ill., Sept. 1, 1891.  
A deed from David McWilliams, of the President and Board of Trustees of the Village of Dwight, to that portion of the north half of the section 14, of township 36 north, range 7 east of the third principal meridian, as lying west of the extension of Franklin street, containing 100 acres, I. J. & J. depot and east of the highway, as now located on the half section line, running north and south, and bounded upon the south by North street, and upon the north by the right-of-way of the village of Dwight, to be used as a public park for the citizens of the Village of Dwight, was presented and read on motion of Mr. McWilliams, and accepted by the Village Board, and the same was ordered to be recorded. Moved by Taylor, seconded by Diefenbach, that we give Mr. McWilliams a vote of thanks. Carried by all voting yeas.
