Mr. and Mrs. Bynum, a newly married colored couple from Bloomington, were given a reception by the colored people of this city Friday evening.

Mrs. Baxter, the W. C. T. U. speaker, spoke in the M. E. church Sunday and in the court house Monday. Her subject Monday evening was "The True Cause of Hard Times."  
Mert Barton and Ben Coynes were fined \$6.95 each for creating a disturbance Tuesday. Coynes accused Barton of stealing cigars from his barber shop and Barton wouldn't take his word for it.

Last Sunday night, Archie Randolph, well known in this vicinity, went to the C. & A. depot about 9:00 p. m. with the intention of going to Chicago. When he entered the waiting room night operator Moffat, observing that he was drunk, put him out of the depot. Randolph then struck Moffat in the face and ran. Moffat, who is a deputy sheriff, drew a revolver and fired, the bullet making a flesh wound in Randolph's leg. Randolph left for Dwight about 11 p. m. on a freight. From Dwight he went to Chicago on a passenger train. The Alton made complaint and placed a warrant in the hands of Detective Kane, of the C. & A. R. R. Randolph was found in the Chicago Hospital. Detective Kane brought Randolph back on the Hummer Tuesday evening. Squire Louderback fined Randolph \$25 and costs, then suspended the fine. Randolph will claim damages from the C. & A. R. R.

The interest taken in the election of Tuesday far exceeded that of past elections for several years. A larger vote was registered and larger vote polled than ever before. Everybody united in a vigorous effort to have every citizen exercise his or her rights to vote. In Pontiac township the ladies took considerable interest in the fifty-nine as the fact that they cast election, ballots shows. In one precinct where six women voted the votes cast by them were straight prohibitionist. In the other precincts the vote was evenly distributed among the parties. A Western Union wire was run in to the court house and the bulletins taken off. The first reports

indicated republican defeat in the county, but the turn soon came, and the reports of republican majorities threatened no end and no limit "Jinimently I" Best and "Presto change." Knight descended the highest heights of exaltation to the lowest depth of 100,000 minority. Returns from country towns showed even larger Republican vote than was estimated by the various committee men. Nevada was the only township reporting a democratic majority, and that was reduced by many votes.
