Wm. Telford had a horse killed by lightning Saturday night. He carries insurance on his stock in the Home Insurance Co., of New York, which fully covered the loss.

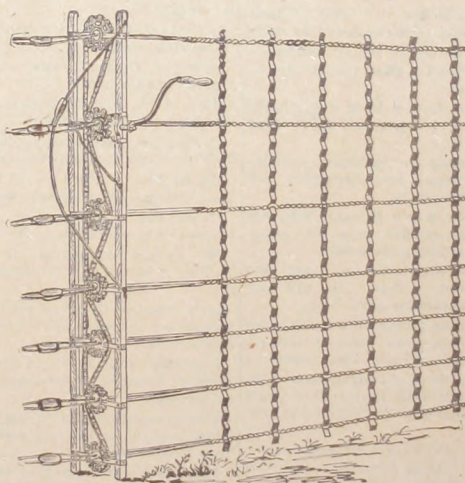
The ball game between the Odell team and Cornell Browns, on Thursday afternoon of last week, resulted in a draw at the close of the 10th inning. Score 11 to 11.
