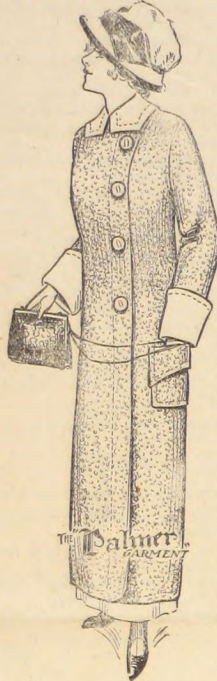

NEWS FROM OUR EXCHANGES
THROUGHOUT THE COUNTY.

Ewald Diemer, sixty-five years old, was on last Saturday adjudged insane in the county court and Monday taken to the state hospital for the insane at Kankakee.

Two inmates of the reformatory at Pontiac escaped shortly before 5 o'clock Tuesday evening and as yet have not been captured. The boys were trustees and when they made their escape were working in the ice house. They are both twenty-two years of age, one five feet ten inches tall and the other five feet eight inches.

Mary Katherine Duffey, the eleven year old daughter of Mr. and Mrs. Hugh Duffey, died at 7 o'clock Tuesday evening at the home of her parents, several miles west of Pontiac, after a short illness. The funeral was held Thursday morning, September 26, from St. Mary's church in Pontiac and burial was made in the Catholic cemetery east of the city.

B. I. Doty, of Peoria, was arrested at Strawn last Saturday afternoon for driving his auto too fast through the town. He tried hard to make his escape past Herman Kuntz with his machine. The auto ran into a ditch and was damaged considerably and had to be dragged to Gilsen City to be repaired. Doty was fined \$9 and arrested by Squire Ruff, and was later committed to Gilsen City because he had no number on his machine.

Mrs. Josephine O'Malley, a resident of Fairbury, has filed a bill in the circuit court asking for a divorce from her husband, Edward O'Malley, on the grounds of extreme and repeated cruelty. The bill states that they were united in marriage September 8, 1891, at St. Louis, Mo.; that they continued to live together until May of 1907, when she was compelled to leave him on account of his treatment toward her. She asks for the custody of their two children.

The Streator police arrested Frank Campbell, colored, Tuesday night on request of Sheriff Patterson. Campbell has been for some time a porter at the Phoenix Hotel in Pontiac. Last Saturday a man by the name of Jay P. Morrill stopped at the Phoenix and it is alleged that some time between then and Sunday evening Campbell secured a sum of money and a ring belonging to this man and is then alleged to have left. When arrested in Streator last evening neither the money nor the ring were found on Campbell. He is being held awaiting further developments. Morrill is said to be a traveling man residing at Minneapolis.

Antone Kemnetz, a well known young farmer residing about four miles east of Strawn, was accidentally shot at a charivari party at the home of Mr. and Mrs. Henry Stehley, the latter being a sister of Mrs. Kemnetz, near that place last Saturday evening, dying about twenty minutes afterward. Kemnetz, in company with a number of the other neighbors and friends of Mr. and Mrs. Stehley, gathered at the home of Daniel Hornstein last Saturday evening for the purpose of charivaring Mr. and Mrs. Stehley, who were married in this city on the day previous. In the company were Frank and Ernest Kemnitz and Fidel Hummel, all three of whom carried shotguns. While engaged in their sport at the Stehley home these guns were discharged a number of times. During the sport Antone Kemnetz was accidentally shot and died about twenty minutes later. A physician was called, but the injured man had passed away before he arrived. Coroner Snyder, of Pontiac, went to Strawn Sunday and held an inquest.

At the examination of the witnesses no one knew positively who fired the shot which caused the death of Kemnetz, as there were a number of them. All were positive, however, that the shooting was accidental. The coroner's jury, composed of John Walsh, foreman; Henry Hornickie, Henry Gerbracht, William Hanna, Charles Boyston and Fred Hornickie, returned a verdict according to the above facts, that the deceased came to his death by the accidental discharge of a shotgun and held no one to be to blame. The deceased was thirty-five years and eighteen days old and leaves a wife and one child.

CENTRAL ILLINOIS CONFERENCE CLOSES.

Rev. G. H. McClung, of Tonica, appointed as Dwight's New Pastor.

The Central Illinois M. E. Conference closed its session in Normal Monday morning. Rev. R. A. Brown, former pastor in this city, goes to Grand Ridge and Rev. McClung, of Tonica, was appointed as Dwight's new pastor. Rev. Brown has been pastor of the M. E. Church here for the past two years and during his stay has made many friends who will be sorry to hear of his departure today for Grand Ridge.

Rev. McClung who was appointed as our new minister comes from Tonica highly recommended, having stayed at that place for the past three years.

The report of the treasurer showed that the amount paid by the church in the several districts of the conference for the support of pastors, superintendents and bishops, ministerial support and pastors salaries, amounted to \$667,553.

In regard to individual salaries the First Methodist Church of Pontiac pays the largest salary to its pastor of any church in the conference, \$2,600. Streator, in the Pontiac district, pays \$2,000, and Normal comes next in order with a salary of \$1,800. In the Kankakee district the First Church of Kankakee pays \$2,500, with Fairbury paying the next largest salary of \$2,000.

Rev. Dr. John H. Ryan perhaps holds the record for longest continuous pastorate, being assigned to Pontiac for the tenth consecutive year, with one year's pastorate previously served there.

Rev. R. B. Williams was reappointed district superintendent.

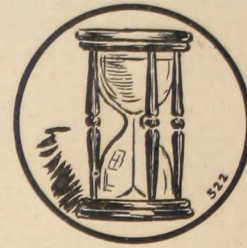

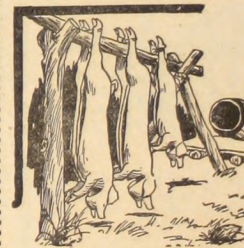
