Obituary of Mrs. George Conant.

Harriet Newell Blair was born in Rochester, Lorain Co., Ohio, February 11, 1833, and departed this life March 20, 1913. She, with her parents, went to Massachusetts, where she lived until she was sixteen years of age, then moved to Wisconsin or the "Far West" as it was called, where she lived and was married to George Thatcher Conant July 3, 1856. In December of 1867 they moved to Dwight, Ill., where she has lived for forty-five years, watching the village of Dwight grow and prosper until it became a city. The old pioneer home, where the prairie sod was never turned, could tell the story of her life.

Her husband preceded her to the home beyond February 26, 1906, since which time she made her home during the winter with her daughter, Mrs. Edward Horton.

She had one brother living in Minnesota, who at the time of Mrs. Conant's funeral passed through another sorrow in the death of his daughter, who passed away at nearly the same hour Mrs. Conant did.

The simple trusting faith in Jesus Christ of the deceased, and her quiet disposition was her life.

Funeral services were held Saturday afternoon, March 22, at the residence of Mr. and Mrs. Edward Horton, Rev. F. F. Farrington officiating. The hymns sung were "Rock of Ages," "Abide with Me," and "Nearer my God to Thee."

The body was then taken to Oak Lawn cemetery for burial.
